### Meeting Agenda

**Call to Order:** By Chairman Ron Mjelde.

**Adopt Minutes:** Ron Mjelde made a motion to approve the minutes from the September 2018 Regular Meeting. Tom Curran seconded the motion and all voted in favor. **Motion passed.**

**Landfill Manager's Report & Equipment Report:** Rod said the new <sup>Pump</sup> bump on the Dozer was working good. Metal piece on the Compactor wore out again. Prison MPM looked at it and said they could haul it to the prison to repair it. DEG inspected the landfill and said if passed, Rod passed out the report for all to review. Rod also reported that Barry Damschen said everything looked good as to how he wanted to see it.

### **Continuing Business:**

**Concrete:** A Bill was received from Jim's Skidsteer Services for the cutting of cement for a doorway.

**Nyquist Land:** County Attorney Lewis Smith reported we had numerous studies that still have to be done for DEQ. Need the survey from Will Danforth which has been a problem getting. Lewis said he will give him to the end of this week. If he does not receive it, he'll have Ries & Associates, P.C. do the survey.

**Fence:** A proper fence is needed to stop the debris. Charlie reported that we could get guard rail from the Garrison construction from the replacement rail. There was a question as to how it would be fenced in.


**Snow Plow:** Tom reported that the State Surplus Auction had a snow plow but that it was a large highway plow. He'll keep looking for one.

**PRDD-Tires:** Rod is keeping track of the PRDD containers coming into the landfill for billing. Ron Mjelde asked about the tires and the amount per tire at \$3.00 and \$50 to \$60 per container. Non-local is \$7/yard. Lewis indicated that an Interlocal agreement might be needed for the tires.

**New Business:** Rod will give Donita the numbers for containers delivered from PRDD for billing. Proposed burn was posted in the Silver State Post, burn permit done and waiting for affidavit of approval. Ron reported that the Postal Service will receive a letter notifying them of dumpster removal due to non-payment of DLDD billing.

**Financial Review:** Jen reviewed July and August Reports.

**Adjournment:** The meeting was adjourned at 5:45 pm.
