After edits are compiled, all boards will meet and discuss changes.

While everyone was together discussion was had on the 2023 fair book, classes added, rules changed, etc. The helmet rule under the Department A – Horse Bulletin Point reading "It is required that riders under the 4-H age of 18 wear an ASTM certified/SEI approved helmet whenever mounted – Courtney Berg made a motion to remove this rule from the fair book. Carolyn second- Motion passed to remove this rule.

It was also discussed that each specific county rule does not need to be printed in the fair book. There was also discussion how future edits should come about the fair book. A drop box was suggested be put in the BRP – more will be discussed at a later date.

We then entered into our regular board meeting. Kelley read minutes from the March meeting. Stacey motioned to approve minutes as read. Courtney second – minutes approved as read.

Correspondence

Mutual Aide Agreement for facility use in case of and emergency. Stating that in the event of an emergency – this agreement supersedes any previously scheduled activities on fair grounds or in the buildings. Letter supporting the City of Deer Lodge Transportation Alternatives Program – Regarding path along main street down past fairgrounds. Old Business

Fair fundraiser has been moved to next year. Stacey touched base about the meeting with Commissioners/Extension Agents in regards to relationship letter from Powell County. Nothing will be

Fair book- Under Market Poultry- Division AB15 Katie would like to add Market Turkey and Market Goose. Dave Miller motioned to add Market Turkey and Market Goose as sub classes in the Market Poultry section. Motion passed. Eaf discussed the Breeding Goats and Sheep judging. Eaf motioned to swap the Breeding Goats and Sheep judging to Breeding Sheep and Goats judging. Courtney second. Motion passed. There were no more edits or corrections at this time. Dave motioned to approve the Tri-County Fair Book with the updated edits and additions along with the removal of the helmet rule in Department A of the Horse section. Maggie second- fair book approved for 2023.

Courtney will touch base with Jan and Gerald in regards to Bingo. Amanda is working on the escape room details.

Maggie will be in charge of working on the 501-C3

Katie talked about the rabbit and chicken cage issue- still a work in progress, but working towards a better system for the chickens and rabbits.

New Business

Board appointments- Missy Merrill and Darah Nelson both submitted letters of interest. Katie motioned to accept Darah Nelson as our new member at large. Stacey second. Welcome Darah.

Carolyn second- motion passed Old blue panels in the BRP belong to the Fairboard, the board will hold onto these for a few years before replacing.

Other
