<u>Private Bail Bonds Fee:</u>	\$20.00 - This Fee is if Bond is Paid by Private Individual
<u>Bail Bondsman Fee:</u>	\$40.00 - This Fee is Charged if Being Paid by a Bondsman
<u>Pay to Stay in Jail:</u>	\$69.00 - Males or Females

Writ of Execution: \$100.00 Per Person / Per Location / Per Service

Sheriff's Sale: \$200.00 – Sheriff's Sale
