Commission Minutes November 2023

Deer Lodge, Montana

November 6, 2023

The Board of Commissioners for Powell County, Montana, met in regular session at 9:00 o'clock A.M. Present: Presiding Officer Daniel G. Sager and Members Ruth E. Koehler and Ralph E. Mannix, Jr.

James Wangerin was in discussing a shift from centrally assessed tax burden to personal property. He presented multiple documents. He is asking for support to call a special session of the legislature to solve this problem. County Attorney McEnery addressed Mr. Wangerin's questions on budgets. The 2022 audit is complete. The 2023 audit is in progress and nothing can be done until it is complete. Andy Wangerin discussed the ambiguity of the Montana Tax Code. He wants a special session to clarify this as soon as possible instead of with the courts. Attorney McEnery commented that the court should make the determination of the laws. Andy Wangerin thinks the special session would address this in a timelier manner. James Wangerin is hoping that people will realize that the tax burden is shifting to home owners. He wants a special session and/or legislative delegation. He wants to see residential property tax rate reduced from 1.35 to 1.11. In attendance for this meeting was Gavin Roselles, Emily Wood, Luke Ulatowski, Phyllis Thompson, Becky Beard, Ann O'Toole, Katherine Bair, and Jim and Andy Wangerin.

Senator Beard gave an update. She assured everyone they are working on this lawsuit in every way possible. There may likely be an intern legislative committee bill to clarify the 95-mill problem. She assured everyone there will be clarity on the 95 mills.

Emergency Medical Service (EMS) update was given. Jennifer Spring presented the financial picture. Heather Quigley expressed concerns about the use of disposable equipment vs reusable supplies. Rand Dickson stated they could do a cost analysis. Dr. Johnson will be the medical director for Helmville so they can get their certification. Call volume is up about one hundred calls from last year. Commissioner Mannix questioned the use of a proportional amount of funds that is supposed to go to ambulance services providers who respond in the north end of the county. Tony Pfaff says they will do that if the hospital ever quits losing money and the hospital will not give any money at this time. The only thing on their expense sheet is direct expenses, not any overhead for administration. In attendance was Heather Quigley, Gavin Roselles, Katheryn McEnery, Tony Pfaff, Jennifer Spring, and Rand Dickson.

Heather Quigley also requested a correction of the July 17, 2023 minutes that read "Becky Beard, Mandy Montgomery, Brian Quigley and Heather Quigley were in to discuss Ambulance services" be changed from ambulance services to ambulance levies.

The bid for electrical updates at the fairgrounds was opened. Only one bid was received and it was from Desilva Electric of \$75,360. Commissioner Mannix moved and Commissioner Koehler seconded the motion to accept the bid. Motion carried.

Commissioner Sager reported on the Beaverhead-Deer Lodge working group meeting in Butte and on the MT Forest Collaboration Network annual meeting.
