THE ONLY ITEMS THAT MAY BE BROUGHT INTO THE DETENTION FACILITY BY THE INMATES OR BY SOMEONE FROM THE OUTSIDE ARE AS FOLLOWS. ANY ITEMS OTHER THAN THE ABOVE THAT ARE BROUGHT TO THIS DETENTION FACILITY FOR AN INMATE, WITHOUT PRIOR APPROVAL FROM THE JAIL COMMANDER OR SHERIFF, WILL NOT BE ACCEPTED.

MAIL

INCOMING MAIL WILL BE OPENED AND SEARCHED FOR CONTRABAND. OUTGOING MAIL WILL REMAIN UNSEALED FOR INSPECTION. ONCE IT IS INSPECTED IT WILL BE SEALED AND ENTERED INTO THE POSTAL SYSTEM FOR DELIVERY. NOTES WILL NOT BE ACCEPTED. ANY OUTGOING MAIL THAT IS SEALED WITHOUT PROPER AUTHORIZATION WILL BE RETURNED TO THE INMATE FOR COMPLIANCE WITH THIS ORDER AND THE RULES AND REGULATIONS MANUAL OF THIS DETENTION FACILITY.

MAIL TO AND FROM AN ATTORNEY, THE GOVERNOR, THE ATTORNEY GENERAL, A JUDGE, SHERIFF MAY BE SEALED AND WILL NOT BE INSPECTED. HOWEVER, IF THE SHERIFF HAS ANY REASON TO BELIEVE THAT SUCH MAIL CONTAINS CONTRABAND, THE MAIL MAY BE OPENED AND INSPECTED FOR CONTRABAND IN THE PRESENCE OF THE INMATE TO WHOM THE MAIL IS ADDRESSED. THE MAIL WILL NOT BE READ. ALL OTHER INCOMING MAIL WILL BE OPENED AND INSPECTED TO ENSURE THAT PROHIBITED MAIL IS NOT ENTERING THE FACILITY.

INMATES WITHOUT FUNDS WILL BE PROVIDED POSTAGE FOR THREE (3) LETTERS PER WEEK FOR PERSONAL CORRESPONDENCE AND UNLIMITED POSTAGE FOR CORRESPONDENCE TO COURTS, ATTORNEY, COURT OFFICIALS AND OTHER PUBLIC OFFICIALS. USE OF THE U.S. POSTAL SERVICE IS THE ONLY ACCEPTABLE MEANS OF WRITTEN COMMUNICATION. NOTES WILL NOT BE ACCEPTED.

INMATES WILL INDICATE THEIR NAME AND THE FOLLOWING ADDRESS ON THE OUTSIDE OF THE ALL OUTGOING ENVELOPES.

CONTRABAND

TO MAKE, OBTAIN OR POSESS CONTRABAND WHILE IN THE CUSTODY OF THE POWELL COUNTY DETENTION FACILITY, OR TO INTRODUCE CONTRABAND INTO THE DETENTION FACILITY IS A FELONY.

CONTRABAND MAY BE DEEMED AS ANY ARTICLE OR SUBSTANCE BROUGHT INTO THE FACILITY OR ISSUED BY THE FACILITY WHICH HAS BEEN ALTERED IN ANY FORM OR MANNER SO AS TO RENDER SUCH ARTICLE OR SUBSTANCE A DANGER TO ANY PERSON OR TO THE SECURITY OF THE COUNTY DETENTION FACILITY.

NO INMATE OF THE COUNTY DETENTION FACILITY SHALL POSESS ANY ARTICLE OR SUBSTANCE EXCEPT THOSE ISSUED OR BROUGHT INTO THE FACILITY AFTER BEING APPROVED BY THE JAIL COMMANDER OR SHERIFF.
